Participation Rate Improvement Plan (ESSA) • Review/Revisit PRIP • Implementation	10 minutes 2020-2021 PRIP Cosg	 Jim, David and Pam presented to BOE at last meeting regarding our ESSA status and plan. Per the state, we must have 95% participation in the state tests in order for us to be removed from this designation. Our past 2 years of participation had 50-60% opt out rate. The state is directing us to implement a plan to increase participation in state assessments. The attached plan was adopted by the BOE in May 2020. Many BPT members had concerns over the development of the plan at that time. Much of the plan specifically falls on Jim. One part of the plan cites researching what districts have 95% participation. Participation rates from 2019 make the most sense to research as it was our last "normal" year for data collection. David has been given the task of researching districts across the state. BPT members can volunteer to help with said research. Many BPT members voiced concerns on their own ethical beliefs on state testing, especially given the current state of things. Jim will construct a brief parent survey as well. Janeen has volunteered to help with that.
Referral Data • Referrals to date • PBIS	10 minutes	Reviewed referral data for the past several years. More reflection is needed to assess the data. Is it a small number of students who are repeat offenders? Is it a result of the pandemic and time away from school? What can we do to correct behaviors? It is important to follow up with parents for disrespectful behaviors and write the referrals. We need to stay on course and vigilant in curbing misbehaviors. Discussion of PBIS helping to build in a hallway booster lesson. If we can curb misbehaviors at least at the start of class.
